

Commander's Column

Greetings brothers,

By now most of you should have heard that I have been appointed as the commander of the 7th Military District. Brother Ken Early stepped down as commander due to his recent assignment to Germany as part of his ongoing commitment to the US Air Force and the security of our nation. Ken felt that he could not devote the attention he desired to his duties as district commander while he was engaged in operations overseas.

I have enjoyed working with Ken. He has always been a good friend and a devoted member of the SVR. I am pleased to appoint Ken as the District Chaplain because we can continue to work together and benefit from Ken's insights in a somewhat less demanding capacity. Due to our strength of our district Ken will receive an administrative reduction in rank in the SVR to second lieutenant.

I also thank Ken for recommending me to Major General Grim for the post of District Commander. I also wish to thank the rest of my staff for their support including two men who are being promoted to the rank of Captain in recognition of their service effective April 7, 2012: Captains David DuBrucq and Phil Hinman. David will be the new District Adjutant and Phil will be my Chief of Staff. 2LT Ted Golab is staying on as District Inspector General.

Currently the District has roughly 80 men deployed in three companies in Tennessee, Georgia and Florida. We should be able to increase that strength. I believe that the SVR is unique among those who don Union uniforms. Others who do so are camp guard units and re-enactors. These units have differing reasons for doing what they do. Some, like us, wish to preserve and teach history, while others may simply do it for fun. The thing that makes us unique among these organizations, that really make us the elite, is our common bond in being descendants of those heroes who fought to save the Union during The Great Rebellion. Re-enacting units and camp guards come and go, but we are the bearers of the legacy of the Sons of Veterans and Ultimately the GAR. It is our mission to keep green the memory of the boys in blue that was handed down from the GAR that sets us apart from the others.

I have been thinking recently about how we strengthen our presence. Obviously recruiting is important, but in these busy times many either don't feel they have the time or possibly the knowledge to start a unit from scratch which is often what happens as SVR units tend to spring up in various SUVCW Camps. This is a good thing, but due to reporting requirements and other administrative duties small units starting out often struggle and founder. Several units this year have disbanded. Clearly we need a better approach.

I believe that one of the best things we can achieve is to have a few strong units of good quality rather than rush to form many small new units. I would encourage all brothers of the SUVCW to join the SVR. If there is no unit affiliated with their camp we should encourage them to join one of the three existing companies in the district. Often camps are close enough geographically that it is possible for SVR units from different camps to belong to the same company. Where this is not geographically practical, of course, we would like to see a new company formed there. I believe that there is nothing in the regulations to prevent a squad sized detachment of SVR members to belong to a stronger company. Perhaps in this way we can grow the existing companies into units nearing company size. I don't know that any companies will achieve a paper strength of 100 to 120 men in the near future, but we can probably get these to the size of veteran companies that were sometimes only 30 to 50 men. Think of the possibilities that would open!

We could do so much more and draw more attention to our cause in this way. So talk to your friends in the SUVCW Camps and encourage them to join your company. We have a solid professional staff in the district and three solid companies with strong company commanders. Let's build on this solid foundation and see if we can grow to at least 100 men by 2013. This is the sesquicentennial of the Civil War. We should have a great opportunity to expand our presence and public awareness of who we are

Amzi D. harmon Company at New Smyrna for 2012 Sesquicentennial

One hundred and fifty years ago, Union and Confederate forces fought at New Smyrna (now New Smyrna Beach), Florida. The National SUVCW Sesquicentennial Committee approved this as the 2012 Department of Florida Sesquicentennial Signature Event.

Amzi D. Harmon Company, SVR, manned a display table at a Department of Florida tent and awning with Commander Farrell and Sesquicentennial Committee Chairman Heiple from 10:00 am to 4:00 pm Saturday March 17, 2012.

A 1:00 pm ceremony was begun by Department Commander Farrell's opening remarks. Private Whitlam (serving as Department Chaplain) offered an invocation. Harmon Company Commander Ward and Private Slavin posted the Colors, with musket-men First Sergeant Linscott and Private Irons. The musket-men then marched to the lagoon's bank forming a musket squad with Corporal Custer and Mike, a guest Confederate musket-man re-enactor. Sesquicentennial Chairman Heiple read the names of those killed in this action: LT Budd, and Seamen Burch and Marlow of the USS Penguin, and Master Mather, and Seamen Arnold, Bates, Brown, and Deloris of the USS Andrew, as well as a pilot whose name was not recorded (no Confederate losses were reported). A wreath was laid at the stone marker. The musket squad fired three volleys. Private Whitlam offered a benediction, and Commander Farrell concluded the ceremony. Private Hans served as photographer.

The 19th Annual Battle At Narcoossee Mill began Friday March 23, 2012 with a school program of authentic camps, display tables, sutler's row, and related demonstrations. Saturday March 24 continued the authentic camps and displays for the public with a ladies tea, musicians performing Civil War era music, a battle, dusk artillery fire, and a barn dance. A second battle was conducted Sunday March25. The weather was close to perfect, especially compared to the2011 persistent rain. Boy Scouts of America troops and the public from Florida and a variety of other states attended. Department of Florida Commander Farrell and Brother Heiple manned a Camp 4 display table. Harmon Company Commander Ward is shown with Private Shaffer and his Camp 7 display table of Civil War era muskets and rifles. Corporal Custer served as event Master of Ceremonies. Privates Whitlam and Slavin also manned the display tables, and Brothers Jeff Chandler and Chris Maniaci pitched a tent in the authentic campsite. This is an annual event. The mission is to remember Civil War combatants and encourage public awareness by providing visual displays and actions, and by being available for discussion, and to identify prospective members.

Note: the formation at parade rest, and the infantryman beside the Colors are representative of the re-enactors from a variety of states that comprised the authentic campsite and participated in the two-day battle.



150th Anniversary of the Battle of Shiloh

On March 31st and April 2nd, 2012, the cannons roared once again in McNairy and Hardin Counties in Tennessee, site of the April 6th and 7th, 1862 Battle of Shiloh. More than 6,000 re-enactors took part in two events depicting the Battle.

The clash at Shiloh (Pittsburg Landing) started on the morning of April 6th, 1862. Federal forces under the command of General U.S. Grant were caught by surprise in attack by General Albert Sidney Johnston's confederates in one the Civil War's most famous "cliffhanger" battles. In a statement describing the battle, General Grant said "In numbers engaged, no such contest ever took place on this continent."

Although severely battered on the first day, Union forces held. General Johnston had died from a mortal wound in fighting on the 6th and had been replaced by General P.G.T. Beuaregard. The following day, April 7th, 1862, the fortunes of battle were reversed. Reinforced by newly arrived troops from Nashville under the command of General Don Carlos Buell, Grant's federal army went on the offensive with a 6:00AM attack by General William Nelson's Division. Union troops advance and threw back the confederate line. Beauregard, who was unaware that Grant had been reinforced during the night, ordered a counterattack. Nelson's advanced was stopped, but his battle line held firm and would not break. Beauregard had suffered heavy casualties and realized he could not prevail. He made the decision to withdraw toward Corinth, Mississippi.

Civil War author and historian Shelby Foote called Shiloh "a great big fistfight with two big mobs slugging away at each other."

Historian Bruce Catton noted the following, "Now the war had come down to uninstructed murderous battle in the smoky woodland, where men who had never been shown how to fight stayed in defiance of all logical expectation and fought for two nightmarish days. And because they had done this the hope for an easy war and a cheap victory was gone forever."

The nation was utterly stunned by the magnitude of the battle and the number of casualties. Some 23,700 men were killed, wounded or missing after its conclusion. Americans on both sides began to realize for the first time that the war would be long, bloody and costly.

General Johnston became the first full general in American history to be killed in battle. A bullet struck an artery behind the knee and bleeding into his boot he died in about 20 minutes.

The Union suffered some 13,000 casualties and the Confederate Army of Mississippi had lost 10.700 men. The raw courage and tenacity of the largely inexperience and undertrained troops who fought at Shiloh can never be overstated.

General Grant's mastery of the Confederate forces continued; he had beaten them once again. The Confederates continued to fall back until launching their mid-August offensive.

Portraying General Grant

Have you ever imagined what it might have been like to fill the shoes of General Grant? Dr. Curt Fields, a member of Fort Donelson Camp 62 and the 10th Regt, Tennessee U.S. Volunteers, SVR, is someone who might be able to provide us with some insight into that question. He has portrayed the general at several sesquicentennial events and received high praise from all quarters for the authenticity and dedication with which he presents the Grand Army of the Republic's famous commander. I have had the honor of appearing with him and now have the privilege of introducing him to all of you. In his own words, Dr. Fields, Curt to those who know him, tells us who he is and why he portrays the general.

Who is Dr. Curt Fields? "I am a native of Memphis, TN.

I have had careers in:

* Education as a teacher from the Jr. High school to the University level. I still teach Sociology for the Univ. of Memphis as an adjunct assoc. professor and teacher education/prep courses for Belhaven Univ. at the Memphis campus. (Small Presbyterian college based in Jackson, MS since 1883 w/campuses in several cities).


* I am a recently retired HS school Principal.

* I was a Memphis Police Officer for four years (I was an MPD hostage negotiator for the MPD) and a Reserve Police Officer for twenty years after my regular service. I hold the record of being the only Memphis Police Officer to have a Ph. D.

* I have two degrees from Memphis State University and two from Michigan State University.

What was it that made you take an interest in American Civil War?

I have always been a History student in general and a rabid Civil War student more specifically."

Why General Grant?

"I had an 'epiphany' after having met President Lincoln (Dennis Boggs, also a member of the SUVCW and 10th Tennessee, SVR) at the 145th Anniversary of the Battle of Chickamauga and having my picture taken with him. It, rather suddenly, occurred to me that I am General Grants' height, weight and body style. I thought that if I grew a beard and wore the appropriate uniform, that I just might look like him. Well, I did and I do.

Had I looked like someone else in the War, I would have given serious thought to portraying that individual(s).

I always had a respect for General Grant. However, after committing to portray him and studying him extensively, I have come to genuinely like him. He really was a nice guy!"

When did you first begin portraying the general?

"I made my first appearance as General Grant at Fort Donelson in February of 2010."

How did you prepare for his Character?

"I read, and continue to read, his Memoirs (and Julia's Memoirs), as well as everything I can find of what others wrote about him, e. g. books, interviews, statements made by the General and/or by contemporaries who knew or met him.

I particularly like to read the books by his staff and those close to him during the War because they tell of his persona, habits, and demeanor. THAT is the 'stuff'' I like to know about the General because that is how I determine how to conduct myself when portraying him in order to be most true to how General Grant actually acted, moved, talked, etc. (for example: did you know that his favorite breakfast was cucumber slices dipped in cold pickle brine?) I also study his biographies and the other books written by past/present authors about Grant.

My presentations as Grant are, as much as possible, quotations from what he said, or wrote, himself. I minimize myself and try to stay as closely as possible to what General Grant actually said about a given situation.

When I have to make a statement that he did not himself make, I rely on my studies to say as closely as possible what he might have said in that situation or question. That is where the study pays off because, hopefully, I know him so well, I can approximate how he thought and not say anything he wouldn't have said."
